1. With reference to Section 45 of the Khyber Pakhtunkhwa Public Procurement Regulatory Authority (KP-PPRA) Act, 2012, this notice is hereby issued for the information of all participating bidders in response to the above-mentioned tender.
2. The tender was opened by the Procurement Committee on **November 05, 2025**, in the presence of the bidders or their authorized representatives. The Committee examined all submitted documents and declared **all four bidders** as qualified. It is noted that the bidder/representative from **M/s Ishtiaq Printing & General Order Suppliers** was absent during the opening; however, their documents were duly received and considered accordingly for competition.
3. The Procurement Committee prepared a **comparative statement** based on the bids downloaded from EPAD, which is reproduced below. The Committee has recommended issuing notices to all four bidders, who applied through EPAD, to submit their samples for the items for which they qualified as lowest bidder/s in the Office of the Assistant Director (Examinations), DCTE Abbottabad. **on November 10, 2025, at 11:00 AM.**
4. The final decision regarding the **award of the contract** shall be made on the basis of the **evaluation of the submitted samples.**
5. Any aggrieved bidder may submit a written complaint to the **Grievances Redressal Committee** of this office within **ten (10) days** from the date of issuance of this notice, in accordance with the **Khyber Pakhtunkhwa Public Procurement Grievances Redressal Rules, 2017.** No complaints will be entertained after the expiry of the stipulated period.
